COLLECTION AND STORAGE OF PERSONAL DATA, AND AIMS AND PURPOSES OF THEIR USE

When you visit our websites <http://www.claudiaweaver.com>, <http://www.claudiaweaver.de>, <http://www.claudiaweaver.at>, your browser will automatically send information to the server of our website. This information is temporarily stored in a so-called log file. The following information will be thereby recorded without your intervention and stored until automated deletion: IP address of the requesting computer, date and time of access, name and URL of the retrieved file, website from which access takes place (referrer URL), browser used and, if necessary, the operating system of your computer as well as the name of your computer and Access provider.

We only disclose your personal data to third parties if: You have provided your personal information pursuant to Art. 6 para. 1 sent. 1 lit. A DSGVO have expressly consented to the transfer pursuant to Art. 6 para. 1 sentence 1 lit. to DSGVO assertion, exercise or defense of legal claims is required and no grounds for acceptance insists that you have an overriding legitimate interest in not disclosing your information for which case that for the transfer according to Art. 6 para. 1 sentence 1 lit. c DSGVO is a legal obligation, as well as this legally permissible and in accordance with Art. 6 para. 1 sentence 1 lit. b DSGVO for the execution of contractual relationships with you is required.

AFFECTED RIGHTS

You have the right:

in accordance with Art. 15 DSGVO, to request information about your personal data processed by us. In particular, you can provide information on the processing purposes, the category of personal data, the categories of recipients to whom your data has been disclosed or will be the intended storage period, the right to rectification, erasure, limitation of processing or contradiction, the existence of a right of appeal, the origin of their data, if not collected from us as well as the existence of automated decision-making including profiling and, where appropriate, require meaningful information about their details;

according to Art. 16 DSGVO the correction of incorrect or completion of your stored with us immediately to request personal data;

accordance with Art. 17 DSGVO, to demand the deletion of your personal data stored by us, as far as not the exercise of the exercise of the right to freedom of expression and information, to fulfill a legal obligation, for reasons of public interest or to assert, exercise or defense of legal rights is required;

DATA SECURITY

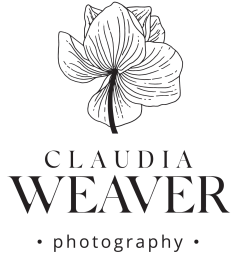
